Among the three assembly constituencies going to bypolls, JD(S) has considerable support in Basavakalyan and Sindagi. Gowda's stand triggered speculations of a tacit understanding with the BJP as it came just a day after his party senior, MLC Basavaraj Horatti, was elected to the legislative council chairman post. In a tactical move, the BJP provided support for Horatti's win. But Gowda put up a weak defence saying "I'm now working to save the regional party and my focus till the next election will be the same.

against the BJP and the Sangh Parivar. Her holy dip is seen as party's attempt to adopt a soft Hindutva line to revive Congress fortunes in the Hindi heartland, particularly Uttar Pradesh.
