(B) We refer to the shares held by Shri Arun Kumar Jatia in his own capacity and shares held by Shri Arun Kumar Jatia as Executor of the will of Smt. Poonam Jatia, as disclosed previously in the quarterly shareholding patterns of the Company. In this connection, we have now realized that - 38,530 equity shares are shown as held in the name of Shri Arun Kumar Jatia (as Executor of the will of Smt. Poonam Jatia) (These shares were originally held in the name of Shri Arun Kumar Jatia jointly with Smt. Poonam Jatia and after demise of Smt. Poonam Jatia in December 2014, it is held in the name of the first holder i.e. Shri Arun Kumar Jatia) And - 39, 000 equity shares are shown as held in the name of Shri Arun Kumar Jatia. (in his individual name) (These shares were originally held in the name of Smt. Poonam Jatia jointly with Shri Arun Kumar Jatia and after demise of Smt. Poonam Jatia in December 2014, it is held in the name of the second holder i.e. Shri Arun Kumar Jatia (in his capacity of Executor of the will of Smt. Poonam Jatia) Accordingly, post demise of Smt. Poonam Jatia, the demat account statements of both the separate accounts show the shares to be held in the name of Shri Arun Kumar Jatia with the same PAN, for the reasons stated above. However, recently, while going through the old demat statements, we find that the shareholdings are as follows - 39,000 equity shares are shown as held by Smt. Poonam Jatia as first holder and Shri Arun Kumar Jatia as second holder. (Pursuant to Smt. Poonam Jatis demise in December 2014, it is these shares, which are held by Shri Arun Kumar Jatia, as Executor of will of Smt. Poonam Jatia) And - 38,530 equity shares are shown as held in the name of Shri Arun Kumar Jatia as first holder and Smt. Poonam Jatia as second holder. (Pursuant to Smt. Poonam Jatis demise in December 2014, these shares are held by Shri Arun Kumar Jatia, in his own single name) Thus, in effect, inadvertently the figures indicating the number of shares held by Shri Arun Kumar Jatia in his own name and the number of s hares held by Shri Arun Kumar Jatia as Executor of will of Smt. Poonam Jatia have been interchanged in the disclosures made by the Company. Since, pursuant to the demise of Smt. Poonam Jatia, the demat account statements of both accounts are in the name of Shri Arun Kumar Jatia due to reasons stated above, we did not decipher the mistake until recently.
